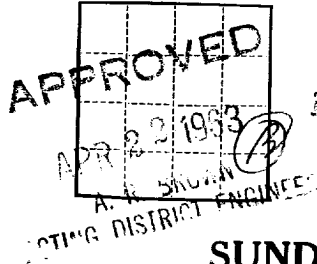

The elevation of the derrick floor above sea level is 5709 ft.

DETAILS OF WORK

This well was drilled to total depth of 2645 feet with no commercial shows of oil or gas. 4-5/8" surface casing was set at 35 feet with 25 sacks of cement. Propose to plug and abandon by filling hole with heavy mud and placing cement plugs as follows:

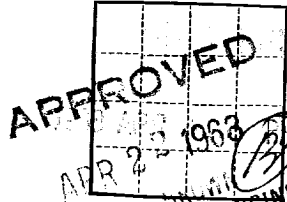
- 25-sack plug at depth 2535 feet
- 25-sack plug at depth 1400 feet
- 25-sack plug at depth 570 feet
- 20-foot plug at depth 20 feet
- Erect regulation well marker

Well drilled to total depth 2'65. 8-5/8" casing set at 35' with 25 sacks.
Well was plugged by filling hole with heavy mud and placing cement plugs as follows:

- 25-sack plug at 2135-2136 feet
- 25-sack plug at 1300-1400 feet
- 25-sack plug at 470-570 feet
- 6-sack plug at 0-20 feet

Fractured regulation marker and cleaned location.
Well was plugged and abandoned on April 11, 1963.
