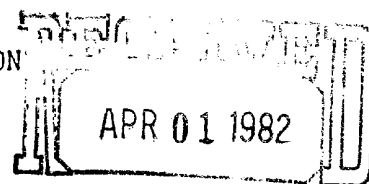

Box 1952 Abilene, Texas 79624 drilled a well to test for hydrocarbons and/or carbon dioxide gas and said well is described as the State-Kirkman (H) No. 1, being located 2310 feet from the East line and 2310 feet from the South line of Section 28, Township 4N, Range 12E, NMPM, Torrance County, New Mexico.

2. That said well was drilled to a total depth of 494 feet, and that casing has been set and cemented as follows:
8 5/8 23 pds. set at 305 feet circulated 300 sacks of cement back to surface.

3. That the present whereabouts of the operator is not known to the landowner and that it is the desire of the landowner to have the above described well transferred to him for conversion to his use as a water well. The landowner will leave casing in the well as follows:

4. That when the landowner has converted said well in accordance with the provisions of Paragraph 3 above it will so notify the Oil Conservation Commission of the State of New Mexico on Commission Form C-103.

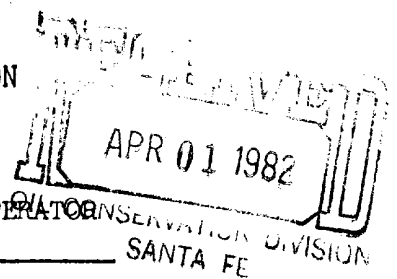
