carbon dioxide gas and described as the State-Kirkman No. H#1, being located 2,310
feet from the South line and 2,310 feet from the East line of Section 28,

County, New Mexico.

3. That said well was drilled to a total depth of 494 feet, and that cas-
ing has been set and cemented as follows:
8 5/8" 23 lb. casing set to 304.32 feet.

4. That operator and landowner have made an agreement whereby operator

further provides that operator is to plug said well back to a plugged-back total depth of

Paragraph 4 above have been complied with to his satisfaction.
