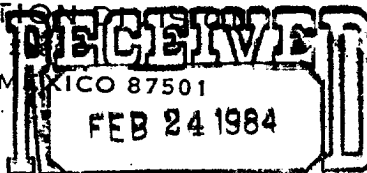

Total 1900' Set 1269' 4 1/2" and cemented with 35 sacks. Drilled out Plug and had some water so set A cement Plug at about 1280' After setting Plug I had Pierson Cementing Pressure Test to 1900#

I want to drill out plug at 1280' clean hole and bail or pump hole dry to 1900' and see how much water and oil comes into hole.
Will try to start about Feb.28/84
