The following intervals were perforated : A- 774ft., B-662-663ft., C-635.5-634.5ft., D-624-625ft., E-619-620ft., F-572-573ft., G-549-554ft. Starting at bottom with perforation A working up to G the well was perforated, tubing run, packer set acidized, and swabbed. No hydrocarbons of commercial value were produced. After each set, that section was squeeze cemented with 2 sacks of cement. Perforation zone G (549-554 ft) swabbed back fresh water. Convert this to a water well.
