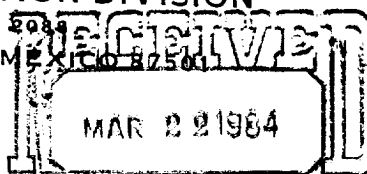

Blow Out Prevention Program:

Following the completion of surface casing cementing a Shaffer model 39 manual single ram B.O.P. will be installed. Drill string will be fitted with a bottom hole check valve.

The mud program will include drilling with salt-gel adequately weighted to controll anticipated formation pressures. A gas detection system will be used.

#1 Cement will be from TD up to tie the string to the surface casing

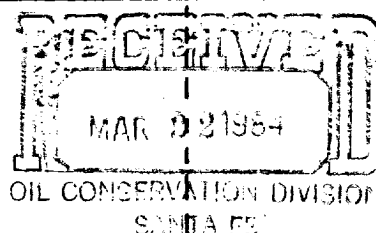
