FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

We propose to pull the 8" casing and fill the hole with mud back to 1650'. We will place a ten sack cement plug. We will then pull our 10" casing, fill the hole to 1600' where we will place a ten sack cement plug, ~~and fill the hole back to 1600' where we will place a ten sack cement plug.~~ We will continue to fill the hole back to 1350' where we will place a ten sack cement plug. We will then knock off and pull our 13-3/8" casing, fill the hole back to 700' where we will place another ten sack cement plug. We will then attempt to pull our 16" casing, and if this pipe can be pulled, we will fill the hole back to 300' where we will place another ten sack cement plug and continue filling the hole to the surface with mud. We will fill the cellar and erect a pipe monument set in cement.
