Gentlemen:

You have informed us that it is your obligation to plug the following wells drilled by or controlled by F. D. Myers, located as follows:

- F. D. Myers Milbourn No. 1 C-11-6N-7E, Torrance County, New Mexico
- F. D. Myers Smith Pece Well No. 1 L-12-6N-7E, Torrance County, New Mexico

We therefore submit the following proposal:

- 1. At our sole expense we shall furnish equipment, 1900° of 2-3/8" tubing for spotting plugs, cement, mud, water, shots for shooting pipe off, well markers, and labor to plug the wells, as well as furnish dozer to cover pits, and will do the same in good workmanlike manner in accordance with the rules and regulations of the Shate of New Mexico Oil Conservation Commission.
- 2. We make a firm bid of \$6,555.50 to plug said wells, and have knowledge that we are liable for all expense in plugging.
- You will not be obligated to make any payment whatsoever to us until the wells have been plugged and accepted by a representative of the Oil Conservation Commission.
- 4. We will not be responsible for salvage equipment or any other property pertaining to the aforementioned leases after work is completed.
- 5c We will recover all salvageable pipeppossible and bid on same if for sale.
- 6. We shall commence work in the near future and complete the same as expeditiously as can be done. We shall have the status of an independent contractor, and will have considered to be your employee.
