The drilling bond to cover the above designated well has not yet been received by the Commission, which permitted Mr. Orville Lee to proceed with drilling operations upon said well, with the understanding that the bond, of course, would be supplied. Nearly two months have gone, and no bond. I trust that the supplying of this bond will not be further delayed.

It was our understanding at the time of permitting Mr. Lee to proceed with the well that if he could not supply the corporate surety bond himself, some of his associates would do so.
