## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

6 5/8" casing was set, landed + cemented at 1428 ft. Drilled out plug and found to be dry. 5 1/2" casing landed and cemented at 1939 ft. 2 in. Drilled out plug and tested formation at 1965 ft. to 1989 ft. No production of E.O.O. A little color of oil on the water. Drilled out to 2062 ft. No further showing. After shooting well from 1965 to 1989 ft. found no showing. Cut off 5 1/2" casing at 1450 ft. Pulled out. Plugged 5 1/2" casing with wooden plug. Cemented with 2 sacks of cement. Cut off 6 5/8" casing at 1250 ft. Pulled out cemented, drove in wooden plug. Cemented using 2 sacks of cement. Pulled 8" casing at 765 ft. Plugged 10" casing at 65 ft. and left 10" in hole.
