P.S. The Bureau of Mines has received samples on this well up to 2363' and we would also like to have the samples from this depth to TD.

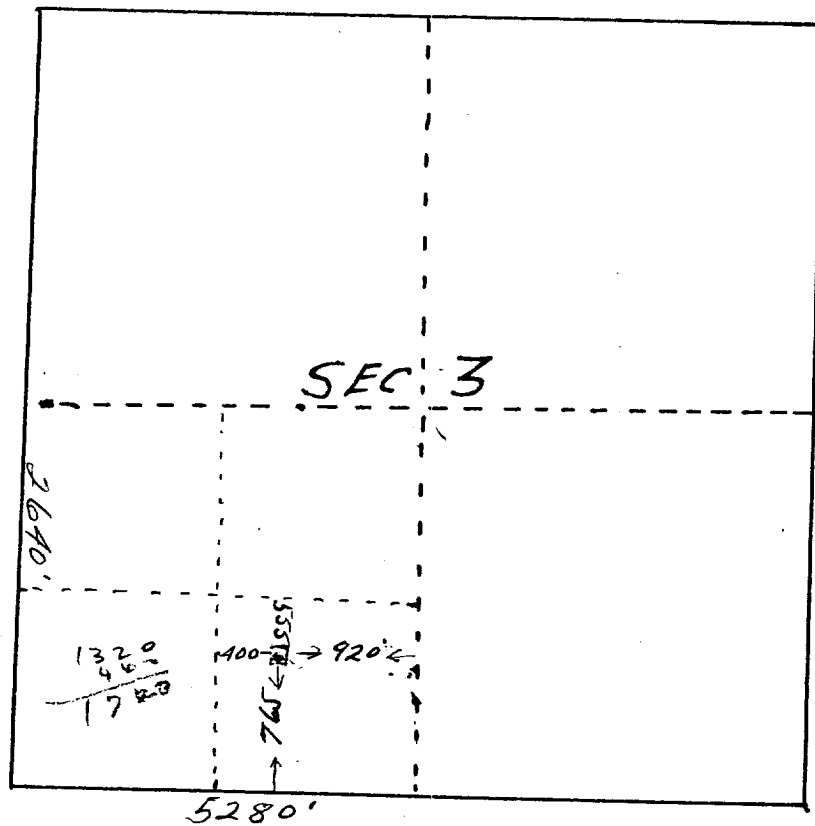
