FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Plug Well leaving hole to water sand as water well for Landowner Clarence O. Davis, who accepts said well as a water well according to the proposed plan of plugging set out hereinbelow:

Fill hole with mud from bottom to 751.

Bridge and cement plug are to be set between 720 and 751 but immediately below 718, the end of the 8" casing, then pull said 8" casing from 1 to 718.

Next, if possible, pull the 10" casing from 1 to 333 and next pull the 12" casing from 1 to 132, if possible to pull said 12" casing.

The landowner proposes to set suitable surface casing to prevent top of well from caving.
