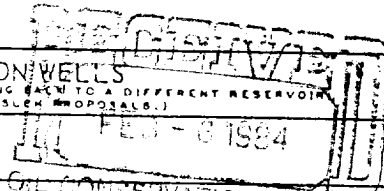

Propose to check tubing and packer for leaks as follows:
Move in service unit and drop standing valve and pressure test tubing. Release packer and pull tubing and packer. Redress packer. Run in with 1 joint fiberglass tailpipe, packer, seating nipple, tubing, crossover and tubing. Load the backside with 2% KCL inhibited water. Set the packer and finish loading backside to surface. Pressure test backside for leaks to a max of 500 psi. Swab if necessary and flow overnight to pit at a max rate. Shut in well.
