On 8-25-79 Baker & Taylor Drilling Co. (Rig #16) spudded a 12-1/4" hole at 2:00 p.m. Drilled to a TD of 362' and ran 8-5/8" 24# casing set at 362'. Cemented with 200 SX Class C cement with 2% CACL and additives. Plug down 3:15 a.m. 8-26-79. Circulated 20 SX. WOC 18 hrs. Tested casing with 1000# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling.
