On 11-5-80 CO<sub>2</sub> in Action (Rig #18) spudded a 12-1/4" hole. Drilled to a TD of 715' and ran 8-5/8" casing set at 713'. Cemented with 450 SX Class H cement. Plugged down 2:20 p.m. 11-7-80. Circulated 25 SX. WOC 19 hrs. Tested casing with 900# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2616' and ran 5-1/2" casing set at 2616'. Cemented with 1050 SX Class H cement. Plugged down 10:00 p.m. 11-11-80. Circulated 150 SX. Currently waiting on completion unit.
