On 10-5-80, CO₂ in Action (Rig #18) spudded a 12-1/4" hole at 3:30 p.m. Drilled to a TD of 700' and ran 8-5/8" casing set at 700'. Cemented with 400 SX Class C cement. Plugged down at 5:30 p.m. 10-6-80. Circulated 45 SX. WOC 20 hrs. Tested casing with 1000# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2614' and drill pipe stuck. Backed off at 2077'. Ran wash pipe to wash thru bridge at 1205'. Left Bit, 18 drill collars, and crossover sud and 97' of wash pipe and shoe..

Propose to P X A per the following procedure:

Spot a Class C cement plug 1100'-650'.
Spot a Class C surface plug.
Install P X A marker.
