Propose to kill well and release packer and pull out of hole tubing and packer. Run in hole with bit and tubing clean out well to plug back total depth. Perf intervals 2236-52, 2254-62, 2268-83, 2284-2309, 2310-44, 2346-53, 2356-82, 2420-38. Run in hole with tailpipe and packer and sand and 2-7/8 tubing to surface. Swab well and stimulate with 27 tons liquid CO2. Flow test overnight and return to production.
