On 10-29-80 CO in Action (Rig #18) spudded a 12-1/4" hole. Drilled to a TD of 700' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down at 1:30 p.m. 10-30-80. Circulated 125 SX. WOC 18 hrs. Tested casing with 800# for one hour. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2600' and ran 5-1/2" casing set at 2595'. Cemented with 700 SX Class H cement. Plugged down at 3:55 a.m. 11-4-80. Circulated 200 SX. Currently waiting on completion unit.
