On 11-18-80 Moran Drilling Co. (Rig #52) spudded a 12-1/4" hole 2:00 p.m. Drilled to a TD of 710' and ran 8-5/8" casing set at 710'. Cemented with 500 SX Classs C cement. Plugged down at 8:30 p.m. 11-19-80. Circulated 25 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2650' and ran 5-1/2" casing set at 2650'. Cemented with 1100 SX Class C cement. Plugged down at 7:45 p.m. 11-27-80. Waiting on completion unit.
