On 11-12-80 CO₂ in Action (Rig #18) spudded a 12-1/4" hole at 12:00 noon. Drilled to a TD of 738' and ran 8-5/8" casing set at 738', Cemented with 400 SX Class C cement. Plugged down at 7:00 a.m. 11-14-80. Circulated 30 SX. WOC 22 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2532' and ran 5-1/2" casing set at 2506'. Cemented with 900 SX Class H cement. Plugged down 5:15 a.m. 11-20-80. Circulated 50 SX. Currently waiting on completion unit.
