On 10-31-80, Moran Drilling Co. (Rig #52) spudded a 12-1/4" hole at 5:30 a.m. Drilled to a TD of 690' and ran 8-5/8" casing set at 690'. Cemented with 500 SX Class H cement. Plugged down 4:30 p.m. 11-1-80. Circulated 75 SX.WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2625' and ran 5-1/2" casing set at 2581'. Cemented with 600 SX Class H cement. Plugged down 2:00 a.m. 11-7-80. Circulated 240 SX. Currently waiting on completion unit.
