On 11-22-80 CO₂ in Action (Rig #18) spudded a 12-1/4" hole at 5:00 a.m. Drilled to a TD of 711' and ran 8-5/8" casing set at 711'. Cemented with 450 SX Class C cement. Plugged down 2:15 a.m. 11-23-80. Circulated 50 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2560' and ran 5-1/2" casing set at 2560'. Cemented with 950 SX Class C cement. Plugged down 6:00 p.m. 11-29-80. Circulated 175 SX. Currently waiting on completion unit.
