On 1-28-81 Swanson Drilling (Rig #3) spudded a 12-1/4" hole at 10:15 p.m. Drilled to a TD of 706' and ran 8-5/8" casing set at 704'. Cemented with 500 SX Class H cement. Plugged down at 8:00 p.m. 1-29-81. Circulated 150 SX. WOC 23 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2651' and ran 5-1/2" casing set at 2651'. Cemented with 100 SX Class H cement. Plugged down 11:50 p.m. 2-5-81. Currently waiting on completion unit.
