On 12-15-80 Moran Drilling (Rig #52) spudded a 12-1/4" hole at 11:00 p.m. Drilled to a TD of 701' and ran 8-5/8" casing set at 701'. Cemented with 500 SX Class H cement. Plugged down at 12:45 a.m. 12-16-80. Circulated 70 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2450' and ran 5-1/2" casing set at 2449'. Cemented with 670 SX Class H cement. Plugged down at 10:00 p.m. 12-22-80. Circulated 250 SX. Currently waiting on completion unit.
