On 2-6-81 Moran Drilling (Rig #52) spudded a 12-1/4" hole at 4:00 a.m. Drilled to a TD of 710' and ran 8-5/8" casing set at 710'. Cemented with 500 SX Class H cement. Plugged down 11:30 a.m. 2-7-81. Circulated 150 SX. WOC 18 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2711' and ran 5-1/2" casing set at 2711'. Cemented with 775 SX Class H cement. Plugged down 10:00 p.m. 2-12-81. Circulated 208 SX. Currently waiting on completion unit.
