Perf intervals 2357-2390, 2393- 2422, 2426-2447, 2456-2493, 2495-2501, 2503-2508, 2511-2516, 2544-2546, 2549-2554 RIH 1 jt fiberglass tailpipe, coated packer & 2-7/8" tubing to surface, land tailpipe at 2210'. Set packer at 2175 ft, stim with 22 tons C02. Flow test overnight & return well to production.
