Propose to kill well with 2% KCL water & release packer & POH tubing and packer. Perf intervals 2273-2294, 2298-2313, 2315-2336, 2345-2410, 2434-2468. RIH 1 jt fiberglass tailpipe, coated packer and 2-7/8" tubing, land tailpipe at 2120' and set packer at 2090'. Stim with 22 tons liquid CO2. Flow test overnight & return well to production.
