On 11-15-80 Moran Drilling (Rig #56) spudded a 12-1/4" hole at 10:30 a.m. Drilled to a TD of 705' and ran 8-5/8" casing set at 705'. Cemented with 450 SX Class H cement. Plugged down at 2:50 p.m. 11-16-80. Circulated 75 SX. WOC 18 hrs. Tested casing with 900# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2648' and ran 5-1/2" casing set at 2648'. Cemented with 850 SX Class H cement. Plugged down at 10:45 p.m. 11-23-80. Circulated 70 SX. Currently waiting on completion unit.
