On 4-3-81 CO2 in Action (Rig #19) spudded a 12-1/4" hole at 8:30 p.m. Drilled to a TD of 705' and ran 8-5/8" casing set at 704'. Cemented with 500 SX Class H cement. Plugged down 2:30 a.m. 4-5-81. Circulated 200 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3425' and ran 5-1/2" casing set at 3425'. Cemented with 1250 SX Class H cement. Plugged down 1:30 p.m. 4-11-81. Circulated 310 SX. Currently waiting on completion unit.
