MIRU-SU 10-10-86. Kill well and pull tubing and packer. Run 2-7/8" workstring and packer set at 2169, CCL and Run RFC valve. Pump 200 gals 15% NEFE HCl acid and 500 gals 2% KCL Pad and 2000 gals KTrol and 500 gal 2% KCL flush via tubing at 20 GPM while simultaneously pump 2% KCL water down annulus at 26 GPM. Max tubing pressure 1390 psi casing vac. shut-in overnight. Pull tubing and packer. Run production equipment and flow test well.
