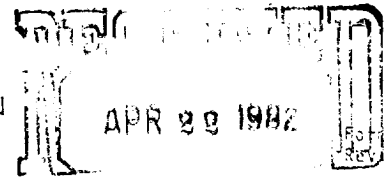

Moved in service unit 3-30-82. Pulled tubing. Perforated 2169'-79' with 2 JSPF. Ran packer and 3-1/2" tubing. Set packer at 616'. Fractured with 16000 gal 40# x-linked gel with additives and 16500# 8/12 sand. Pulled tubing and packer. Ran seating nipple and 2-3/8" tubing. Tubing landed at 2122'. On 4-4-82 turned well thru a separator. Moved out service unit 4-5-82. Flow tested for 167 hrs. and flowed 5577 MCF, 445 BLW and 91 BFW. Ran 72 hr. BHP buildup test 4-11-82 thru 4-14-82. Well shut-in.
