MIRUSU, kill well as necessary, NUBOP, release packer, lay down production tubing and packer, run workstring to 2,192 feet, spot 58 sacks of class C cement, pull workstring, WOC, run workstring, tag cement, cement should be above 2,121 feet, pressure test casing to 500 psi, displace casing with corrosion inhibited fluid, pull workstring to 1,596 feet, spot 10 sacks of cement, pull workstring to 30 feet and fill casing with cement, NDBOP, RDMOSU, cut off wellhead, install PXA marker, cut off well anchors and clean location.
