Moved in service unit 4-28-82. Pulled tubing. Perforated 2140'-66', 75'-83', 87'-89', 92'-2209', 18'-32', 36'-43', 47'-52', 59'-64', 69'-81', 86'-2306', and 15'-21' with 1 JSPF. Set a packer at 605'. Fractured well with 21000 gal 40# x-linked gel with additives and 24000# 8/12 sand. Pulled packer. Cleaned out sand 2150'-2345' with sand pump. Ran 2-3/8" tubing and seating nipple. Tubing landed at 2083'. Moved out service unit 5-5-82. On 5-6-82 turned well thru a separator and flow tested for 167 hrs. Well flowed 10812 MCF and 48 BLW. Ran 72 hr. BHP buildup test 5-13-82 thru 5-16-82. Well shut-in.
