Opened well to tank and perforated 2134-50', 2174-44', 2246-70', 2273-84', 2293-98', 2330-36', 2351-58', and 2367-80' with 2SPF. Killed well with 40BW 27% KCL. Re-ran production equipment. Tubing landed at 2017' and packer set at 1986'. Pressure tested casing 1000 psi-ok. Left well open to tank overnight. Recovered estimated 45 BW. Stimulated with 25 tons CO₂ and 450 ball sealers. MOSU 7-10-85 and returned well to production. Operations completed 8-13-85. PAWD: 2181 MCFD.
