Propose to kill well and release packer and pull out of hole tubing and packer. Run in hole with bit and tubing and clean out well. Perf 2134-50, 2174-2244, 2246-70, 2273-84, 2293-98, 2330-36, 2351-58, 2367-80. Run in hole with 1 jt tailpipe and packer and sand and 2-7/8 tubing to surface. Swab well and stimulate with 26 tons CO2. Flow well overnight and return well to production.
