On 3-10-81 Salazar Drilling (Rig #13) spudded a 12-1/4" hole at 4:00 p.m. Drilled to a TD of 707' and ran 8-5/8" casing set at 707'. Cemented with 500 SX Class H cement. Plugged down 9:55 a.m. 8-11-81. Circulated 220 SX. WOC 18 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2535' and ran 5-1/2" casing set at 2535'. Cemented with 700 SX Class H cement. Plugged down 6:15 a.m. 3-17-81. Circulated 250 SX. Currently waiting on completion unit.
