On 3-26-81 Salizar Drilling (Rig #13) spudded a 12-1/4" hole at 6:30 p.m. Drilled to a TD of 724' and ran 8-5/8" casing set at 724'. Cemented with 500 SX Class H cement. Plugged down 3:45 p.m. 3-28-81. Circulated 146 SX. WOC 18-1/2 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2590' and ran 5-1/2" casing set at 2590'. Cemented with 800 SX Class H cement. Plugged down 12:45 p.m. 4-1-81. Circulated 262 SX. Currently waiting on completion unit.
