Moved in service unit 3-22-82. Pulled tubing. Perforated 2293'-2324' with 1 JSPF. Ran packer and 3-1/2" tubing. Set packer at 617'. Fractured with 13000 gal 40# x-linked gel and 8800# 8/12 sand with additives. Pulled tubing and packer. Ran seating nipple and 2-3/8" tubing. Tubing landed at 2259'. Moved out service unit 3-26-82. On 3-28-82 turned well thru a separator and flow tested for 140 hrs. Well flowed 2055 MCF and 15 BLW. Ran 72 hr. BHP buildup test 4-3-82 thru 4-6-82. Well shut-in.
