MISU 7-10-85 and killed well with 35BW 2% KCL. Released packer and PDM with production equipment. Ran casing gun and tagged PBTD at 2395'. Perforated 2064-74', 2079-96', 2098-2110', 2120'-38', 2145-69', 2171-92' with 25PF. Killed well with 75BW 2% KCL. Re-ran production equipment. Tubing landed at 1907' and packer set at 1876'. Pressure tested casing 1000psi - ok. Swabbed and flowed back 70BLW. Stimulated with 22 tons CO2 and 335 ball sealers. Flowed back to tank. MISU 7-12-85 and returned well to production. Operations completed 8-13-85. PAWD: 2261 MCFD.
