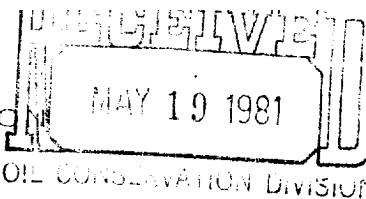

On 4-28-81 Swanson Drilling (Rig #3) spudded a 12-1/4" hole at 2:30 a.m. Drilled to a TD of 708' and ran 8-5/8" casing set at 706'. Cemented with 500SX Class H cement. Plugged down 7:30 a.m. 4-29-81. Circulated 240SX. WOC 18hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2568' and ran 5-1/2" casing set at 2562'. Cemented with 650 SX Class H cement. Plugged down 11:30 p.m. 5-3-81. Circulated 230 SX. Currently waiting on completion unit.
