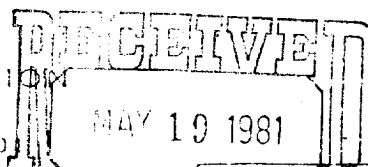

On 4-27-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 2:00 p.m.
Drilled to a TD of 715' and ran 8-5/8" casing set at 715'. Cemented with 500 SX
Class H cement. Plugged down 7:45 a.m. 4-28-81. Circulated 200 SX. WOC 18 hrs.
Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and
resumed drilling. Drilled to a TD of 2557' and ran 5-1/2" casing set at 2557'.
Cemented with 850 SX Class H cement. Plugged down 2:30 a.m. 5-2-81.
Circulated 188 SX. Currently waiting on completion unit.
