On 5-15-81 Salizar Drilling (Rig #13) spudded a 12-1/4" hole at 2:00 a.m. Drilled to a TD of 703' and ran 8-5/8" casing set at 703'. Cemented with 500 SX Class H cement. Plugged down 12:55 a.m. 5-16-81. Circulated 190 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2465' and ran 5-1/2" casing set at 2465'. Cemented with 850 SX Class H cement. Plugged down 4:45 a.m. 5-25-81. Circulated 220 SX. Currently waiting on completion unit.
