Spot 5 sacks of Class C cement from 2230' - 2157', pull workstring to 1,887 feet, spot 15 sacks of cement from 1887' - 1772', pull workstring to 30 feet, fill casing with cement, NDBOP, cut off wellhead, install PXA marker, RDMOSU, cut off well anchors and clean location.
