MISU 3-9-87 and pull tubing and packer. Run casing inspection log and found several holes and CAS04 scale in tubing. Run cement retainer set at 2437. Acidize with 200 gal 15% HCL and pump 500 gal 2% KCL FW and 2200 gal K-TROL. Average injection rate 3/4 BPM. Pull tubing and run tailpipe, packer, ON/OFF tool and 2-7/8" fiberglass tubing. Packer set at 2340. Return to production.
