On 4-20-81 Aztec Rig #50 spudded a 12-1/4" hole at 8:00 p.m. Drilled to a TD of 722' and ran 8-5/8" casing set at 722'. Cemented with 500 SX Class H cement. Plugged down 3:15 p.m. 4-21-81. Circulated 14 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2957' and ran 5-1/2" casing set at 2950'. Cemented with 950 SX Class H cement. Plugged down 9:30 a.m. 4-26-81. Circulated 277 SX. Currently waiting on completion unit.
