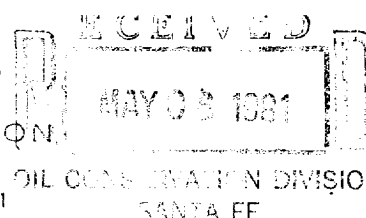

On 4-23-81 CO2 in Action (Rig #18) spudded a 12-1/4" hole at 5:30 p.m. Drilled to a TD of 710' and ran 8-5/8" casing set at 704'. Cemented with 500 SX Class H cement. Plugged down 10:30 a.m. 4-24-81. Circulated 105 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2910' and ran 5-1/2" casing set at 2893'. Cemented with 800 SX Class H cement. Plugged down 4:00 a.m. 4-29-81. Circulated 200 SX. Currently waiting on completion unit.
