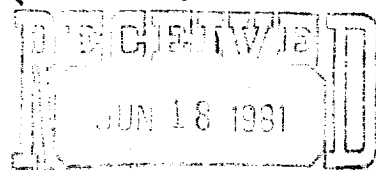

On 6-6-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 3:00 p.m. Drilled to a TD of 720' and ran 8-5/8" casing set at 703'. Cemented with 500 SX Class H cement. Plugged down 2:30 p.m. 6-7-81. Circulated 200 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2570' and ran 5-1/2" casing set at 2558'. Cemented with 750 SX Class H cement. Plugged down 4:00 a.m. 6-13-81. Circulated 245 SX. Currently waiting on completion unit.
