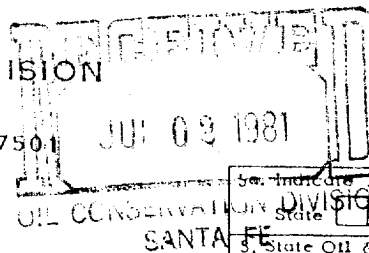

On 6-21-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 7:45 p.m. Drilled to a TD of 712' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down 6:00 p.m. 6-22-81. Circulated 206 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2890' and ran 5-1/2" casing set at 2875'. Cemented with 650 SX Class H cement. Plugged down 6:00 p.m. 6-30-81. Circulated 187 SX. Currently waiting on completion unit.
