On 7-3-81 Salizar Drilling (Rig #13) spudded a 12-1/4" hole at 5:00 a.m. Drilled to a TD of 704' and ran 8-5/8" casing set at 704'. Cemented with 500 SX Class H cement. Plugged down 10:00 p.m. 7-3-81. Circulated 50 SX. WOC 23.5 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2983' and ran 5-1/2" casing set at 2983'. Cemented with 1700 SX Class H cement. Plugged down 7:30 a.m. 7-7-81. Circulated 0 SX. Currently waiting on completion unit.
