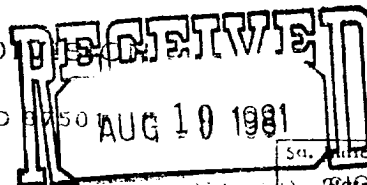

On 7-24-81 Salizar Drilling (Rig #13) spudded a 12-1/4" hole at 10:00 p.m. Drilled to a TD of 705' and ran 8-5/8" casing set at 704'. Cemented with 500 SX Class H cement. Plugged down 1:20 a.m. 7-27-81. Circulated 214 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2520' and ran 5-1/2" casing set at 2520'. Cemented with 900 SX Class H cement. Plugged down 6:45 p.m. 8-10-81. Circulated 230 SX. Currently waiting on completion unit.
